 Continued higher share of funding towards areas with high health inequalities: NHS England will introduce more accurate assessment of need for community health and mental health services NHS England will commission the Advisory Committee on Resource Allocation to conduct and publish a review of the inequalities adjustment to the funding formulae.  Specific measurable goals for narrowing inequalities: All local health systems will be expected to set out during 2019 how they will specifically reduce health inequalities by 2023/24 and 2028/29.
